VI. DIRECTOR'S REPORT

Administration-The issue of clear and effective communication once again evades some staff with personal opinions prevailing over facts. Emphasis has been placed on preventing and correcting misinformation to reduce the damage that is caused when concerns are not addressed.

The support for exam proctoring continues to grow as more students are enrolling in online courses. This service is scheduled through our Branch Librarian, and tests are held in the quiet study room at the East Northport building.

Self-publishing is a booming industry bringing to light many new challenges for public libraries. We continue to focus on strategies to best embrace self-publishing in light of its sheer volume and lack of formal editing and reviews.

Adult and Teen Services-Adult and teen paperbacks are being culled from our patron donations to be sent to the county's jail library. Paperbacks that are donated to the library have many practical uses. Some are distributed at our local train station via our successful Read Ride Return program. However, our Beach Bag Books program has been suspended until next summer providing surplus donations for the county jail.

The 23rd Annual Speaking of Writing Distinguished Author Visit hosted Steve Sheinkin, the celebrated non-fiction author of *Bomb*, the Race to Build and Steal the World's Most Dangerous Weapon. Mr. Sheinkin spoke to over 200 middle school students about his research and writing process. Timing was great since the week prior to his visit, Mr. Sheinkin's most recent book, *The Port Chicago 50: Disaster, Mutiny, and The Fight for Civil Rights*, was named to the short-list for the National Book Award for Young People.

The Suffolk County Police Department K9 Unit was invited to attend the first Teen Advisory Board meeting of the year. Two officers described the care and training involved in working with German Shepherds. After sharing stories about some of the famous cases that dogs helped to solve, everyone was invited outside to see a demonstration of the dog's special skills.

Buildings and Grounds-In preparation of the upcoming winter season, our snow removal equipment is being serviced and ice melt has been ordered.

Shelving has been relocated in the staff areas to accommodate desk reassignments in the Technical Services and Local History areas.

Children and Family Services-Our library is the first public library to join the Reading Specialist Council of Suffolk County which provides a professional forum and network to further the awareness and understanding of literacy issues as they relate to educators and community members. The library's membership will allow a Librarian to attend each of their seven workshops. Attendance will be rotated among the full-time staff based on workshop topics and staff availability.

The Newbery Club hosted George Hagen, author of *Gabriel Finley and the Raven Riddle*, who presented the back story of his work to a group of well-read and articulate students.

Circulation-Two former Library Pages are settling well into the Circulation Department as the newest members of our part time Library Clerk staff. It is so nice to see our junior staff expand their knowledge and advance their careers at the library.

Community Services-The Native American Musicians and Dancers program was cosponsored with the Northport Arts Collation and entertained 60 patrons.

Fifty patrons attended Fireside Friday which was a musical performance of the Great Italian Songbook. Many of these very popular songs were performed in the original Italian language.

The Red Hot Mamas, an all-female dance troupe ranging in age from 54 to 80, entertained an audience of 92 patrons.

The Friends of the Library have purchased new museum passes to the Nassau County Museum of Art and the New York City Fire Museum.

Network and Systems-Meetings have been held with staff requesting additional computer equipment to prepare budget requests for the next fiscal year. Existing computer equipment will continue to be replaced based on our current replacement plan.

Caller ID information has been enabled to allow for the library name to be displayed by some providers when patrons are called.

The Library received a grant from Senator Marcellino, which will be used to purchase new book bins in Northport.

New York State Tax Freeze- In addition to staying below the tax cap for 2015-2016, our patrons will only receive a tax rebate if we also participate in a plan that shows a 1% savings of the total budgets of multiple governmental agencies in a regional Government Efficiency Plan. SCLS is spearheading a plan to see if this is feasible county wide.
